Dress Regulations

Members and visitors who do not comply with the dress regulations will not be served and will be asked to leave the Club premises. The decision of Club staff or management will be final.

The following are unacceptable in the Club at any time:

- Untidy, torn, or dirty clothing or footwear
- Men's Singlets (except in the workman's bar, snooker, smokers and gaming rooms)
- Bare feet
- Pyjamas
- Caps/headwear (except for religious or medical reasons)
- Clothing that displays offensive words or pictures
- Immodest or provocative clothing
- Any other dress that is considered inappropriate by Club staff or management.

House Rules

- Members must conduct themselves in a correct manner at all times. Any unbecoming behaviour will be deemed an offence and may result in disciplinary action from the Board or other regulative bodies.
- Members must produce their membership card when requested by an official of the club.
- If membership is terminated the membership card remains the property of the Club and must be returned to the club.
- Members must carry their card on their person at all times.
- The Staff or Board of Directors of the Club may refuse entry.
- No raffles, lotteries, sweeps or subscriptions list shall be displayed or canvassed within the Club, unless permission has been given from the Board of Directors.
